Following the meeting, the Selectboard will review the Town budget and answer any questions that may be presented.**

- Article 1:** To elect a Moderator
- Article 2:** Shall the voters authorize that current taxes be paid to the Town Treasurer in three equal installments with due dates of August 15, November 15 and February 15 as authorized by 32 V.S.A. § 4871?
- Article 3:** To hear and act upon reports of the several town officers.
- Article 4:** To transact any other business proper to be brought before said meeting.

**The legal voters of the Town of Williston are hereby notified to meet on March 7, 2017, at Williston Central School Gymnasium at 7:00 AM at which time the polls will open until 7:00 PM, at which time the polls will close, to vote by Australian ballot upon the following articles:**

<b>Article 5:</b>	Shall the voters adopt a budget for operating and capital expenses of \$xxx,xxx,xxx for the year beginning July 1, 2017 and ending June 30, 2018?
<b>Article 6:</b>	To elect for the Selectboard one member for a term of two years beginning March, 2017.
<b>Article 7:</b>	To elect for the Selectboard one member for a term of three years beginning March, 2017.
<b>Article 8:</b>	To elect for the Board of Listers one member for a term of three years beginning March, 2017.
<b>Article 9:</b>	To elect for the Library Board of Trustees one member for a term of five years beginning March, 2017.
<b>Article 10:</b>	To elect for the Library Board of Trustees one member for a term of five years beginning March, 2017.
<b>Article 11:</b>	To elect a First Constable for a term of one year beginning March, 2017.
<b>Article 12:</b>	To elect a representative to the Champlain Water District for a term of three years beginning March 2017.
<b>Article 13:</b>	To elect a Town Clerk for a term of three years beginning March, 2017
<b>Article 14:</b>	To elect a Town Treasurer for a term of three years beginning March, 2017
