1)	<u>Town vs. Agency of Natural Resources (Environmental Court #164-10-10)</u> <ul style="list-style-type: none"> • September 30, 2010 - Appeal filed by town regarding state certification of CSWD proposed compost facility. • October 4, 2010 - Notice of appearance on behalf of the CSWD was filed by Jon Anderson, Esq. • November 8, 2010 - Status meeting held • April 13, 2011 - Stipulation of Settlement signed by Mr. Gillies on behalf of the Town. • May 10, 2011 - Stipulation signed by Judge.
2)	<u>Williston vs. VT Department of Taxes, Property and Valuation Review Division (Docket #EQ 09-03)</u> <ul style="list-style-type: none"> • June 7, 2010 - Letter of appeal was sent by town to the Valuation Appeal Board • June 15, 2010 - Appeal letter acknowledgement received • April 2011 - Motion for Summary Judgment filed by Joe Fallon on behalf of Town. • May 16, 2011 - Motion by state to extend time for response to Town's motion and stipulated by Town.
3)	<u>G.B. New England 2, LLC (CVS) vs. Town (DRB) Superior Court Environmental Division</u> <ul style="list-style-type: none"> • December 15, 2010 - An appeal of the DRB decision was filed by Daly and Daly on behalf of their client. • December 16, 2010 - Notice of appearance filed by Paul Gillies on behalf of the Town.
4)	<u>Peter Judge v. Town (Superior Court Small Claims Court Division)</u> <ul style="list-style-type: none"> • December 6, 2010 - Claims damages of \$2,444.23 from emergency response personnel. Case was referred to insurance carrier through VLCT and they have assigned legal counsel. • March 10, 2011 - Hearing held, case postponed. Peter Judge claimed Court Judge assigned to case had a conflict of interest. • June 16, 2011 - Hearing was held. Case was decided in favor of the Town.
5)	<u>Chittenden Solid Waste District vs. Town of Williston (DRB) Superior Court Environmental Division</u> Project involves construction of new bunkers and a pole barn to handle special waste. CWSD is appealing conditions placed on it by the DRB. <ul style="list-style-type: none"> • January 14, 2011 - An appeal of the conditions imposed by the DRB on CSWD was filed by Attorney Jon Anderson on behalf of the CSWD • January 20, 2011 - Notice of appearance was filed by Attorney Paul Gillies on behalf of the Town • May 16, 2011 - Selectboard agreed to have attorney sign a stipulation settling appeal. • May 24, 2011 - Judge signed stipulation.
